Grounds	X			This home is located down a beautiful country lane with grapes growing on the left. It is nestled in a valley with beautiful views. The decks and areas around the home are very well maintained and nicely planted.
Building Exterior	X			The outside of the home is freshly painted and extremely clean.
Living Room	X			The living room has two leather sofas with a coffee table and a flat screen t.v. There are books, dvd's, a computer, a telescope, and a fireplace. The fireplace definitely gives the room a very homey and cozy feel.
Kitchen		X		The kitchen was clean and well stocked with enough cutleries for all residents and staff. The sharps were locked, as was the vanilla. There was a refrigerator stocked with all kinds of healthy food. The cupboards hold many, many cookbooks, spices, oils, etc. It is apparent that there is real cooking going on in this home.
Bedrooms	X			There are four bedrooms at the Ranch. Some boys have their own room and a couple share with another resident. Each resident has a chest of drawers and a closet. There are desks and lamps.
Bathrooms		X		The bathroom was in good repair and clean.
Fire SafetyExtinguishers		X		The fire extinguisher had a current inspection date and accessible.
Fire SafetySmoke Alarms		X		There are smoke alarms in working order as well as carbon dioxide detectors in the common areas and near the furnace, as per regulations.
Fire SafetyEvacuation Plan		X		There is a house evacuation plan that was posted. All the boys know where their exit is and where to meet in an emergency.

Food	X		The food is nutritious and plentiful. There are menus posted and since this is the home of the older boys, many of them help with planning and executing the meals. The refrigerator was stocked with food and leftovers. The large freezer was full.
Emergency Supplies	X		They have emergency supplies such as first aid kits, food and water.
Health Services		X	The boys get routine yearly medical exams and twice a year visits with the dentist. There is also a staff therapist who provides counseling services.
Medications		X	Medications are prescribed by a psychiatrist and administered by the staff. The percentage of residents on psychotropic medications at this inspection time was 75%. The medications are locked and the logbook was up to date.
Recreation (on site)	X		On site there is just about anything a young man would want to do. They have a basketball court and acres of land which can be used for any game at all; soccer, baseball, football, etc.
Outings (off site)	X		The boys have been to Giants games, the coast, movies, fishing, boating, the river, Scandia, shopping, San Francisco.
Education & Classrooms	X		Most boys go to Plumfield Academy, although one goes to Analy and one to El Molino.
Mail/Phone		X	Individualized for each resident.
Discipline	X		There are verbal instructional prompts, which are impressive to watch. Each staff in each home is absolutely familiar with the youths expectations and their own. If that doesn't work, they go to their rooms for a certain amount of time. Occasionally, a youth will advance to OOPS which is house restriction with no public outings, electronics or TV. Although, OOPS is pretty rare in this home with the older youth.
Library	X		Copious amount of impressive titles. This is a home where, if a youth is interested in a certain book or author; the book is purchased for him.

ADDITIONAL NOTES

This home is staffed by people who have worked at Plumfield for years. It is very well run with the boys in complete

understanding of what is expected of them and working hard to become productive citizens of the community.

Community involvement of the residents is encouraged with the young men involved in after school sports, Ceres,

Hospice, and other programs. The boys receive new clothing in the summer and fall. In most residential treatment facilities, staff must attend 20 hours of training per year. However, Plumfield surpasses this requirement by requiring weekly trainings of between $1\frac{1}{2}$ to 2 hours.

An impressive feature of Plumfield to this commissioner is their dress code. Plumfield acknowledges that a healthy self-esteem includes a neat and clean personal appearance. It is evident that they emphasize good personal care by how the boys always look. I have never seen any young man looking unkempt or with attire that could be construed as gang orientated. This could be because these children are able to purchase new clothes for themselves which is different that other group homes I've seen.
